Moving in the Right Direction

We are giving praise to God for the progress "Adam" has made over these past several months! Adam is the young man we wrote about this summer. We became Adam's guardian during an emergency guardianship hearing earlier this year. He suffers from schizophrenia, has a mild cognitive disorder, has misused substances including inhaling gasoline causing injury to his brain, and he has suffered burns over 60% of his body. He spent time living in tents on state land after being banned from metals in the area. He had no in

banned from most motels in the area. He had no income, no friends, and no hope.

After Servants Center became involved, Adam was placed in a boarding home. He was successfully granted disability benefits. A primary care physician has been established, case management has begun, which includes regular visits with a psychiatrist. He was prescribed certain medications which have resulted in a *Huge* improvement in his behavior and well being. He is compliant with the medications, which in itself is big. Adam is happy and cautiously interacts with a couple of residents. Please pray for "Adam", for continued compliance taking his medications, that he will continue to follow house rules, and that we can have more meaningful conversations about spiritual matters and the God that loves him.

Facing Daily Challenges

We became guardian of Mary a year ago. Mary lives in subsidized housing and must maintain her disability income to stay housed. Periodically the Disability Determination Service does reviews to see if an individual is still disabled. Mary refused to go after rescheduling twice. If no in-person review, her disability benefits will stop. No money means no ability to pay rent, resulting in homelessness. Her mental illness is so severe that she won't open her door, has told us to call her but refuses to answer her phone, refuses to talk to us through her door, and pushes papers back to us when we slip important papers under her door. Recently she was petitioned through the court and was picked up and taken to the hospital to be medically cleared and then placed in the psych unit in a local hospital. Because she is hospitalized, the Disability Determination Service has agreed to try a 3rd time after her hospital discharge. Medication treatment began and we are seeing guite an improvement in Mary. She will now talk with us face to face. She has shown enough improvement to be discharged soon. Please pray for Mary, that her paranoia will be managed well with the new medications, that she will be compliant in taking her medications regularly, and that she will agree to let us take her to the Disability Review, as they have agreed to not terminate her benefits just yet due to her hospitalization.

James has been in and out of housing. It's hard to live out on the streets with a wheelchair. Apartments cost more than his disability



benefit. We found a low-cost motel where he doesn't have to share the room. He is happy to have his own space and privacy!

Please help us expand our services so we may help more homeless and mentally ill individuals. Will you consider making a regular monthly or quarterly gift? We just learned as I was writing this newsletter that a long-time client was found deceased outdoors this afternoon. We are saddened with this news. We've had him in many housing placements, but he continued to walk away after a few months. He said he felt safer and in control living outside! *Keeping* our clients housed continues to be a challenge for us.
