#### From the Executive Director

## A Different Kind of Busy

This year started out much like every other year, with much to do, people to care for, people to help off the streets. Then the pandemic hit. It would seem that life stopped. But not for us. Though we initially spent less time out on the streets, we didn't want to abandon the relationships we had been building. The homeless are precious in God's eyes. And we remember that.

We carefully eased back onto the streets wearing face masks and respecting the social distancing recommendations of the government. Many of the homeless we encounter have no understanding of the severity of the virus. We are concerned with their health. This population is particularly vulnerable. So many of those we encounter have ongoing untreated medical issues besides suffering from some form of mental illness.



What has changed is how we tackle our day-to-day duties. What used to be done in person is now being done "virtually", including guardianship hearings, nursing home visitations, client med reviews and care conferences, as well as many medical and psychiatric appointments during the early months of the pandemic. As the summer progresses, we are now able to manage more client appointments in person, including transporting them. Appointments with Social Security are done by phone. We still need to meet with the new client in person and then take the call together. Both virtual and phone appointments have slowed the process a bit.

Technology has challenged us as well. It was when the stay-at-home order was put in place that we discovered not one of our office computer screens is equipped with a camera. Our computers are newer but there was no reason to replace the screens at that time. So our virtual visits have been on our personal cell phones, which can be hard to do when you have 3-6 tiny faces on the screen, or a staff member brings in their personal laptop.

We have been fielding what feels like a ton more phone calls, especially from our clients (many of whom suffer from schizophrenia, paranoia and anxiety disorders). The stay-at-home order has been a real struggle for individuals that we've placed in Adult Foster Care homes. Many don't understand the importance of the order and have been defying it and putting others at risk. Disruptive behaviors and extreme anxieties are reemerging. We've had 6 clients diagnosed with Covid-19 and 2 have passed away.

We face and tackle challenges and the unexpected all the time and have learned to just "roll with it". We know our help is from the Lord and He continues to guide us through.
